To start learning in the selected university, the first thing is required as best to pass final exams at school, and then finally decide on the future profession. When the decision is finally accepted, to start collecting and submitting documents, not forgetting that the adoptive commissions in the country's universities begin their work on April 1, and finish July 25.

These timelines may noticeably vary by the decision of the rector of a university, so that additional information is best to find out individually or by telephone. It is very important to hand over the package of documents on time, otherwise it is unlikely to become a student this year, and no one wants to lose a year.

After submitting documents, we can assume that it has already been done, it remains to wait for enrollment. This requires passing entrance exams, which, as a rule, are conditional, to conclude a

written agreement with the university, and then immediately pay for the cost of learning in accordance with the contract signed earlier. Then find out when the installation session begins, and do not forget to come exactly for new knowledge.

So it is quite obvious that the correspondence form of training today has not lost its relevance, and has a number of weighty advantages and acceptable for many applicants. Ready specialists are also in demand on specialized enterprises, and the level of their preparation is no worse than in full-time graduates.
